

RESOLUTION # 31-2017

Resolution offered by the Supervisors of the Forestry Land and Recreation Committee.

Resolved by the Board of Supervisors of Oneida County, Wisconsin:

WHEREAS, the Oneida County Forestry Department has identified parcel WB 172-2 as a key parcel for the development of a permanent haul road that would span the distance between Washburn Lake Road to Trout Creek Road/County Hwy K (see Attachment A); and

WHEREAS, the development of said road would aid with the transport of harvested timber products from county forest land, and help minimize the impact of forest management activities within the Washburn Silent Sport Area; and

WHEREAS, the county has negotiated with the owners of parcel WB 172-2 and have agreed on a sale price of \$16,300.00; and

WHEREAS, the sale of parcel WB 172-2 is contingent upon approval of the County Board; and

WHEREAS, the Forestry Department has the funds required to purchase parcel WB 172-2 in the department's 2017 budget; and

NOW, THEREFORE, BE IT RESOLVED, by the Oneida County Board of Supervisors that Oneida County approves the purchase of parcel WB 172-2; and

BE IT FURTHER RESOLVED, the funds required to purchase of parcel WB 172-2 shall come from the 2017 Forestry Department Budget.

BE IT FURTHER RESOLVED, that the County Clerk is authorized to sign any and all documents necessary to complete this transaction.

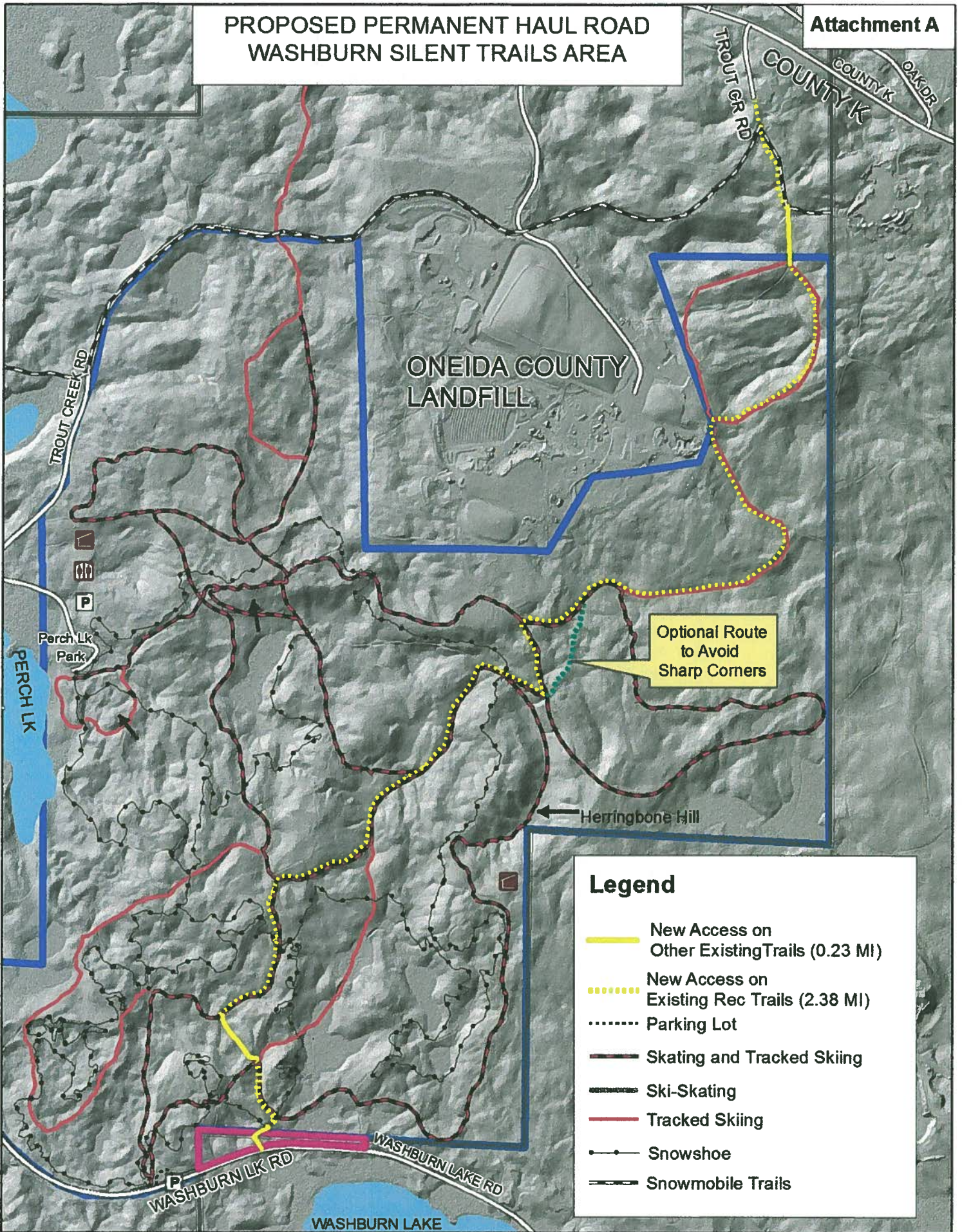
