Call to order:

Tom Rudolph called the public hearing to order at 9:10 a.m., at the Tomahawk High School, 1048 East King Road, Tomahawk, Wisconsin 54487 in accordance with the Wisconsin Open Meeting Law. Rudolph stated the proper media had been notified. Rudolph announced on December 15, 2012, Judge Mangerson issued to Oneida County a ruling in case; Lake Nokomis Concerned Citizen, Inc., et.al.v Oneida County. The court order requires Oneida County to re-process the Lake Nokomis District petition filed by the Lake Nokomis Concerned Citizens, Inc. as if the petition was received on January 9, 2012.

The court order was delivered as a result of problems with the audio recordings of the County Board meetings at which the Lake Nokomis Lake District Petition was considered and ultimately voted upon. Without those audio recordings being able to be transcribed, Judge Mangerson found that the Court would not be able to properly consider the evidence that was presented to the County Board in support and against the petition for the Lake District. As a result, the Court could not make any determinations regarding the alleged impropriety of the County Board decision.

Rudolph explained briefly the process overview and the testimony procedures and the speaking time limits needed to accommodate everyone wanting to give testimony. Rudolph stated this public hearing's purpose is for listening only and no debating would be allowed. Rudolph read aloud the procedures for giving testimony and reminded everyone to remain courteous and mindful to the time limit allowed to each speaker.

Rudolph announced the allowable time frame for speakers: (1) Representative of a Landowner Group-5 minutes (2) Wisconsin Valley Improvement Company-5 minutes (3) Governmental Agency-5 minutes (4) Non-Governmental Agency-5 minutes (5) Individual Landowner-3 minutes (6) Member of General Public-3 minutes.

Discussion/decision to approve the agenda

Motion by Vandervest, second by Pederson to approve the public hearing agenda. All ayes; motion carried.

Mike Fugle, Oneida Corporation Counsel introduced Mary Buryzinski, Court Reporter, from Medford. Fugle stated Mary will be transcribing the proceedings today and may ask for clarifications at various times through out the hearing. Fugle announced the transcription record of this hearing will be available to view at the Corporation Counsel Office on the second floor of the Courthouse.

Mike Fugle, Oneida County Corporation Counsel, read into the public record a total 127 letters were received by the County Clerk's office received and recorded 94 letters in favor of the proposed Lake District and 23 letters opposed to the proposed Lake District. Mr. Fugle was given incorrect totals for letters received. The actual count was 117. The letters are available in the Land & Water Conservation office located in the Oneida County Courthouse on the second floor.

Approximately 120 people signed in at this public hearing.

- **Dale Elliot** **Speaker 38** **in favor**
 He lives in Nokomis. He made a plea to the Committee to really consider what they've heard here today and consider it when they make their final decision. (3 minutes)

Rudolph said the report would be submitted at the February meeting and possibly a decision may be made at the March 21, 2012 County board meeting.
