

**MINUTES OF THE ONEIDA COUNTY
CIVIL SERVICE COMMISSION

CALL TO ORDER

Motion by Dart to refer the three qualified/certified candidates to Sheriff Hartman, second by Rhode. All ayes on voice vote, the motion carried 5-0.


