Motion by Martin to return to open session, second by Rhode. All ayes on roll call vote as follows: Dart aye, Martin aye, Vanney aye, Rhode aye, Melms aye. The motion carried 5-0 and the Commission returned to open session at 1:27 p.m.

Motion by Melms, second by Dart to authorize Chairman Vanney to work on interview questions for applicants with members of the Sheriff's Office. All ayes on voice vote, the motion carried 5-0.

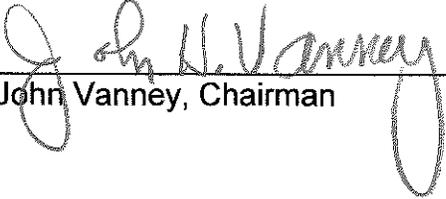
